





EPISCOPAL CHURCH IN COLORADO

The Episcopal Church in Colorado continues to represent Christ to the people across our broad western state of Colorado. Situated in 93 parish outposts spread across the 103,641 square miles constituting our state, Bishop Kimberly Lucas oversees 19,887 souls currently affiliated with the Episcopal Church in Colorado from Denver as our Chief Pastor, Priest and Teacher. Transfiguration is one of 15 Episcopal congregations situated in the Northwest Region, a subset of the larger Diocese. ECOT is currently represented on our regional Executive Committee by Senior Warden Suzanne Gilbert and myself. Transfiguration is the only Colorado multi-campus Episcopal congregation and the sole Episcopal congregation completely resident in interfaith chapels. By canon (church law), ECOT contributes 10% of our unrestricted annual plate and pledge receipts to the ministry of the diocese and 4% to the Northwest Region for our neighboring mountain ministries. In 2024 we contributed \$78,722 and significant staff time to the broader Episcopal church.

The diocesan 2025 budget, approved at last fall's 137th Diocesan Convention, outlines \$3,443,851 in budgeted income and \$3,545,25 in budgeted expense, leaving an anticipated deficit of \$101,400. This budget anticipates over \$2 million in congregational giving and \$900,000 in annual disbursement from the Colorado Trust, something I can explain further if anyone is curious to know more. Bishop Lucas takes her first sabbatical leave from November 5th to March 5th, 2026.

THE VAIL INTERFAITH CHAPEL'S new refurbishments have held up well to a near-constant daily pounding as we expanded our hosting of organizations and events to meet community needs. LEADERSHIP REFLECTIONS

From the **RECTOR**



The Reverend Stuart Brooks Keith III Rector and Senior Pastor

Neither do people pour new wine into old wineskins. If they do, the skins will burst; the wine will run out and the wineskins will be ruined. No, they pour new wine into new wineskins, and both are preserved. Matthew 9:17

2024 was a Jubilee indeed! Praise the Lord from whom all blessings flow! I am pleased to report Transfiguration experienced an uplifting 50th anniversary year filled with Jubilee abundance as we mark the third year of post-pandemic recovery and restoration. By every metric we can measure, we were blessed! Some Jubilee highlights:

- 1. We served 15,948 souls in 2024, the highest number we've ever tallied, a 6% increase from 2023
- 2. We conducted 417 congregational events, again the highest number, a 35% increase from 2023
- 3. Including Christmas, we averaged 210 souls at Sunday worship, again a new high tally, and of interest, 30% of those worshipped with us virtually
- 4. 32 new members joined our parish family through Incorporation, Baptism, Confirmation and Transfer, another robust tally as our congregation grew in 2024
- 5. We received over \$1 million in total 2024 income, a new annual high tally once the 2022 capital purchase of the Parish Vicarage is backed out to compare apples with apples. You transformed a \$62,000 year-end deficit into a \$29,000 operational surplus!
- 6. We received financial support from 164 households including members, seasonal members and friends of this congregation

- 7. Our Board, called a *Vestry*, now stewards almost \$2 million in total congregational asset spread across 2 residences, a clergy study, church office, vehicle and total reserves
- 8. We disbursed \$40,000 year-end gifts to 14 caring organizations through our Clergy Discretionary Fund and Mission & Outreach ministry, almost all local and directly supporting children and youth

For these and other clear signs of God's gracious provisions I am grateful beyond words to you. For this beautiful and peculiar corner of God's global vineyard, I am so grateful. For the new generation of members and servant leaders emerging right now, I am so grateful. For our veteran and unshakeable Vestry and Parish Staff, I am so grateful. In my 30th year of service to this church and community on a two-year work agreement in 1995, I am so grateful!

Now we turn to a New Year and a new Ministry Theme for 2025, New Wine, Fresh Skins. To which new work, new communities and new ministries is God calling us? Transfiguration is coming into her own as a maturing, confident congregation inhabiting her post pandemic leadership profile. It is a great blessing to tentpole our local interfaith community and wider community, our Northwestern Region and Episcopal Church in Colorado and of course our own church. The hard work these past five years is clearly visible....financing, purchasing, and refurbishing a second parish property in the Vicarage. Repair of necessary items in our Rectory. Financing, searching, calling and seating a new Curate no longer new as of this writing. New Letter of Agreement for your Rector. Significant refurbishment of both our Clergy Study and Parish Office. A new (and fantastic!) vehicle. Two newly refurbished interfaith chapels in Vail and Beaver Creek. A more stable financial base for the Edwards Chapel with our lease agreement with Stone Creek Charter School. Expanding worship, program and financial metrics. For the first time in ECOT's history, significant interest income! More significant engagement of our Episcopal state family in supportive ways they seem to appreciate. I look forward to learning about what new wine God has in mind! Thank you for allowing me to serve alongside you in our special place!

From the **CURATE**



The Reverend Michael J. Thomas Curate

Perfusion.

2025 will be a year of Perfusion for me.

Let me just figure out how to link Perfusion to our shared theme of New Wine, Fresh Skins.

Ah, I think I've got it.

Perfusion is a word I learned in late 2024. Most of you potentially reading this know I had a series of strokes, 4 in total, in August and September of 2024. By October 2nd, a neurology team in Denver finally cracked the case; I had an "occluded" mid-cerebral artery. The problem was "*Perfusion*". To the medical community *perfusion* means "the delivery of blood to the capillary bed". So my occluded main cerebral artery was not getting sufficient blood flow to the capillary bed, the very depths of my circulatory system, in my brain. Blood thinners, anti-coagulants and medication to raise my blood pressure were the short-term fix. Surgery, the transplant of a healthy artery to the affected area, was the long-term fix. I had that surgery on 12/26/2024.

So how do I link the medical term "Perfusion" to our church theme of *New Wine, Fresh Skins*?

How about this? In 2025, as I wait for this transplanted artery to take root and get to work, I will do the same in my ministry to our church and community.

Our "Community Meal" in partnership with *La Vida Nueva* on July 26th, 2024 was a great success, but not great enough. It was well attended, but not well attended enough. Folks who participated were so enthusiastic, so many said "we've got to do this again", but we haven't. We had a great, educational presentation about La Vida's youth outreach program, but that wasn't enough. We failed to reach the "capillary bed" discussing issues in our lives and communities. We didn't find a way to perfuse some of the love of ECOT into the 'capillary bed" of La Vida Nueva, or into their youth program. In 2025 I will guide us in this *New Wine, Fresh Skins* initiative until the wine sacks are bursting at the seams.

The "Ol Lentile" Foundation had a "Kenware" sale at the Edwards Chapel. Kenware is the nickname the Foundation uses for Kenyan hand-made goods that Ol Lentile brings to the US for sale, primarily in churches like ours, and 100% of the proceeds from these sales is delivered to the crafter in Kenya. We also donated a ton of books to a newYouth Library in Kenya through Ol Lentile. Both events were a success, but we did not perfuse. I've had no follow-up with Ol Lentile since the Kenware sale. I haven't asked the burning question "what more can we do"? Granted I can use my illness in Q4 of 2024 as an excuse, but this year, in 2025, I need to get down to the capillary bed of Ol Lentile. We can all help ask "what else can we do" of the folks on the margins in Kenya.

In our Pastoral Care initiative we were successful, getting several people from our church family out into the community to visit our extended family, specifically those who cannot get to worship with us on a regular basis. But I / we did not perfuse. Our Pastoral Care Wine Skin is not bursting at the seams yet. In 2025 I will rededicate myself to growing our Pastoral Care team, providing a regular support group for these volunteers who will inevitably "bring home" some of the burdens of the folks they visit, and might need to process some of what they bring home.

In our worship services, I understand we have reached or exceeded our pre-covid attendance, and I've worked hard at learning to chant / sing the Sursum Corda, but Perfusion in 2025 will be more than that. I've been green-lighted to start a Sunday afternoon Episcopal Service at Beaver Creek Chapel starting in March of 2025. I'm going straight past folks who have told me "Oh, we've tried that" and "it will never work" and proceeding. The framework will be a lighter, contemporary service approved by the Episcopal Church with the goal of attracting a new audience, perhaps folks who have been previously wounded or for whatever reason do not know our church and the love of our church. I'll lean on my friends in the 12-step recovery community, who know "God as they understand God" but not "Jesus Christ our Lord and Savior" to build an early base. I'm considering hot chocolate and treats at 2:30 PM to mimic the "Apres Ski" theme that is so popular here in the Vail Valley, perhaps getting people right off the mountain and coaxing them "upstairs" to the Big House to see how we grow in love and worship. Maybe the whole initiative will fall flat, but I've wanted to do this since the first time I visited Beaver Creek Chapel, while I was in consideration for the Curacy here, and I saw only a phone number next to "Episcopal' on the sign out front.

New Wine, Fresh Skins. 2025 will be Perfusion to the capillary bed in everything I do for the Church and the Community.

Our mission this year has been mostly local in recovery mode from Covid, and all the turmoil surrounding the election. We have supported 14 local charities aimed at taking care of people who lack the resources or the opportunity to take care of themselves. Providing food, clothing, housing, medical and behavioral health, Thanksgiving and Christmas meals and Adopt-a-Family have all been targets. The Community Market and Salvation Army also received our support.

On a much smaller scale, our support of food delivery for Covid homes has continued as did our "Bell-Ringers." No matter what situation has come up, we have always supported our community, and such is the tenor of our congregation. While my mission is to identify needs and situations within our community, YOU have always responded to the requests for support and assistance.

Our children's ministry is celebrating this year as we inhabit our theme of Jubilee.

Beginning with Little Lambs and continuing through 5th grade, our children build a foundation of Biblical knowledge and experience liturgy and prayer. *Catechesis of the Good Shepherd* (CGS) is the inspiration for our children's programs and brings them close to Jesus in a profound way. Through CGS, we offer the Bible, prayer, and liturgy through exploratory learning which elicits a response of innate joy in our youngest children and intrigues our older children as they learn about God's loving plan for our salvation and our place in His kingdom.

Little Lambs, ECOT's Christian Montessori program for toddlers, continues to celebrate its status as the first and only childcare or preschool in the Vail Valley to achieve the highest quality rating from the State of Colorado. Little Lambs is one of 126 out of 4171 early childhood programs in Colorado with this achievement.

Why is Little Lambs an important ministry for ECOT? Because Little Lambs is open to one- and two-year-olds, we can introduce families with young children to our loving ECOT parish. As families are seeking baptisms and religious education, they tangibly feel the support that ECOT provides. Also, Little Lambs graduates attend our summer camps and participate in our Christmas pageant, so families continue to see the care that our church offers.

We reached over 123 children through Sunday school and nursery, Lunch Bunch, Little Lambs Christian Montessori toddler program, summer Bible camps, and our joyous



Independent Accountants' Report

Management of the Episcopal Church of the Transfiguration has agreed to and acknowledged that the procedures performed are appropriate to meet the intended purpose of reviewing accounting records and helping the membership complete its bylaw requirements for the year ended December 31, 2023. This report may not be suitable for any other purpose. The procedures performed may not address all the items of interest to a user of this report and may not meet the needs of all users of this report and, as such, users are responsible for determining whether the procedures performed are appropriate for their purposes.

The procedures and associated findings are as follows:

- We reviewed the balance sheet as of December 31, 2023, and the budgeted financial statements, which include actual results for the year ended December 31, 2023. We did not note any material modifications that should be made to the financial statements for them to be reasonably stated and consistently stated with the prior year's statements.
- 2. 2024 wrapped up my last year as your Parish Treasurer. I can't begin to thank you for your overwhelming generosity throughout the past several years and your unwavering trust in me to oversee ECOT's financials. It has been an honor to serve you.

CPA Review for 2023

Our CPA Review for 2023 was completed with no deficiencies or misstatements.

Financial Performance for 2024

Our 2024 financials ended in the positive, which we were able to accomplish with a strong donation push in December. We ran a deficit for eleven months, but by keeping expenses under budget for the year, it made it easier to ultimately end the year in the black.

In 2024, we moved a large portion of our operating fund, most of our designated funds and all of our reserve funds to the care of Morgan Stanley. By making this move we have ensured that we are protected under the FDIC rules as well as being able to invest the monies, receiving some interest income. We will continue to conservatively invest these funds in the future

Reserves and Balance Sheet

In 2024 we combined the Vicarage financial reports with ECOT's to show them all in one report. All the expenses for the Vicarage fall under the Associate Rector's section of the budget.

The ECOT Operating Reserve account was properly funded in 2024 based on our policy of a minimum of four months of operating expenses. We will look at the calculations for 2025 and make any necessary adjustments.

Mission and Outreach

We were able to make our customary year-end Mission and Outreach disbursements to local mission partners.


